**APPLICATION FOR FREE SCHOOL MEALS
NOTES FOR GUIDANCE**

If you receive:

1. Income Related Employment and Support Allowance
2. Income Support
3. Income Based Jobseeker's Allowance
4. Support Under Part VI of the Immigration and Asylum Act 1999
5. Guarantee Element of State Pension Credit
6. Child Tax Credit (**BUT NOT** entitled to Working Tax Credit and your annual income does not exceed £16,190)
7. Working Tax Credit 'run on' - the payment you receive for a further four weeks after you stop qualifying for Working tax Credit.

Then your children will be entitled to free school meals if they are attending state schools and are under 16 years of age on 1st September in the school year. In addition nursery aged pupils attending nursery before and after lunch will also qualify for free school meals if their parent/carer is receiving one of the above qualifying benefits.

Pupils over 16 attending special schools or school sixth forms will also be entitled to free school meals if they or their parents, receive the above benefits.

The County Council is now able to access the Governments benefits eligibility database which will enable an immediate check on your entitlement to free school meals without you needing to produce documentary evidence provided you complete the declaration overleaf. Please be aware that it may take up to 15 working days for your eligibility for benefit to register on the database.

You do not need to complete an application form on an annual basis. Once your children have been awarded free school meals they will continue to receive them throughout their school career unless they cease to be entitled.
